The Council unanimously agreed to recommend no objection to planning application no: B/13/00554/OUT. The Council agreed the recommendation would reference planning application no: B/11/00648/OUT, the original application registered for the site, which was refused permission by the Planning Inspectorate. The Council recognised the proposed development area has been moved in relation to the original application but that the technical issues regarding the overhead cables and the proximity to a Flood Zone 2 remain.

- 25 BABERGH CORE STRATEGY - CONSULTATION ON FURTHER MAIN MODIFICATIONS
Cllr V.Durrant and Cllr J.Kitson had completed a draft response to the Babergh District Council Babergh Development Framework Proposed Further 'Main Modifications' to the Babergh Core Strategy (May 2013) and had circulated it to the Council prior to the meeting. The Council considered the

response and agreed to (i) include a representation regarding Main Modification 20 - Policy CS5 and (ii) to make amendments to Main Modification 21 - Policy CS5a.
