The Parish Council considered a request from Sproughton Community Shop C.I.C., asking for permission to be granted for the shop to install a new vent-hole in the outside wall of the shop unit. The Council agreed, in principle, to the installation of the new vent-hole subject to (i) Sproughton Community Shop C.I.C. demonstrating to the Council that the Babergh District Council Heritage Officer has approved the proposal before the work is undertaken; (ii) assurances from Sproughton Community Shop C.I.C. that the vent-hole to be installed will be fit for purpose; (iii) Sproughton Community Shop

advising the Parish Council of the details of the contractor to undertake the work, before the works are carried out.
