30 REVIEW OF COUNCIL ACTIONS FROM THE PARISH COUNCIL PLANNING COMMITTEE MEETING HELD ON 25TH JUNE 2014

31 TO CONSIDER PLANNING APPLICATION NO: B/14/00763/FHA; 3 VENTRIS CLOSE, SPROUGHTON; ERECTION OF ONE AND HALF STOREY FRONT EXTENSION  
The Council recommended no objections to planning application no: B/14/00763/FHA, in principle. The Council recorded concerns regarding the proposed garage 'in-fill' and the overall reduction in length of the existing driveway and questioned whether the proposed development would meet parking standards. Should the proposed development be granted permission, the Parish Council considers there could be an increase of on-street parking which, combined with the development of the proposed 'Russetts' site, could exacerbate traffic issues in the area.

32 TO CONSIDER BABERGH DISTRICT COUNCIL COMMUNITY INFRASTRUCTURE LEVY (CIL) AND PRELIMINARY DRAFT CHARGING SCHEDULE - PUBLIC CONSULTATION
